



Why do we interview?



- Gather evidence usually of mens rea
- Seek an explanation of behaviour
- Determine who has carried out certain behaviour(s)
- Obtain a confession



What do you need to know?



Proportionate – intrusion into privacy

- Lawfulness can we legally carry out this course of action?
- Accountability why this, and why now? 'If in doubt, write it out!'
- Necessary we need to investigate and we need this evidence to prove our case



Evidence by Interview?

Is the offence already proved in its entirety?

- Is *mens rea* already proved by other means?
- Is the offence one where *mens rea* is not needed?
 - Strict Liability or Absolute Liability offences
 - (Be aware of the need to show *basic intent* and consider *impossible knowledge*.)

<u>Could</u> mens rea be proved by other means?





Evidence is there but...

- The offence is already proved in its entirety... ...but what if someone else was responsible?
- They certainly 'did it'...

...but is there a *statutory* or *general defence*?

• There's no defence...

...but is it in the *public interest* to prosecute?





Why else should we interview?

- Discover an innocent explanation
- Determine responsibility
- Uncover a defence
- Hear mitigation





If you need Mens Rea

...or have major substantive issues to resolve with your suspect...

- Interview in a room
- Interview in two rooms
- Interview remotely (Zoom, Teams &c.) ...otherwise...





Postal 'Interview'

- NOT advised where serious or multiple issues are still to be resolved.
- MAY BE SUITABLE where a single substantive issue may be resolved by a single question.
- IDEAL when you have good *prima face* evidence and no real issues to resolve.





Ideal for some cases of...

- Blue badge fraud
- Education failure to ensure child in school
- Enforcement failure to comply with a notice
- False applications where there is a demonstrable 'non-accidental' act (see *The Ivey Test*)
- Repeat offenders, where knowledge of 'the rules' is, therefore, demonstrable





Postal Statements Under Caution

- TS
- In cases where you have sufficient evidence to proceed without interview, it is still good practice to invite the person to draw to your attention any relevant facts that could effect your decision to prosecute or not.
- As long as the notice is correctly drafted, any response they make (or, indeed, their lack of response) should be admissible to the court.



What to tell 'em



- The notice should set out the offence that is alleged against them.
- It should say that we intend reporting them for consideration of proceedings.
- It should offer them the opportunity to comment, should they choose to, before we make any final decision.
- It should remind them that what they say (or, indeed, if they decide not to answer) may be used as evidence.



The Offence



- The notice should set out the offence that is alleged against them.
- It should contain a factually correct statement of the offence in plain English.
- It should mention the Act the evidence suggests they have contravened.
- *Exceptionally* your letter could, instead, ask a very limited number of questions, <u>although we do not</u> <u>advise this.</u>



The Invitation to Comment

- AS
- Before a final decision is made, you are invited to comment and/or to bring to our attention any information or evidence that you believe might impact on any decision that might be made.
- You are not required to do anything or to respond to this notice, however any comments you may choose to make might be used in evidence.
- You may wish to obtain legal advice before deciding whether or not to reply to this notice or otherwise make any statement.



Voluntary Postal Statement



If you wish to make a statement, please start by writing the following words and signing them 'I make this statement of my own free will. I understand that I do not have to say anything but that it may harm my defence if I do not mention when questioned something which I later rely on in court. This statement may be given in evidence.', then continue with what you would like to say. You may continue on plain paper if necessary, as long as each page is signed and you get someone to witness your signature on each page.



Admissibility Case Law



Direct Holidays plc v Wirral Metropolitan Borough Council [1998] EWHC Admin 456 (28 April 1998) -A Trading Standards case where the company under investigation were asked questions by letter.

[The Trading Standards] "letter of 28th November reminded the Appellants of the caution and suggested they seek legal advice."


A specialist group cracking down on fraudulent claims for small business rates relief across the county has won a national award.






